FURNITURE PROCUREMENT

FOR CAPITAL IMPROVEMENT TO U.S. BANK STADIUM IN MINNEAPOLIS, MINNESOTA

April 20, 2018

A. Project Background and Objectives

In 2012, the State of Minnesota enacted 2012 Minnesota Laws, Chapter 299 (the "Act"), to establish the Minnesota Sports Facilities Authority ("Authority") and to provide for the construction, financing, and long-term use of a new stadium now known as U.S. Bank Stadium (the "Stadium") and related stadium infrastructure (the "Stadium Infrastructure") as a venue for professional football and a broad range of other civic, community, athletic, educational, cultural and commercial activities.

As set forth in the Act, the Authority may make capital improvements to design, development and construction of the Stadium and the Stadium Infrastructure, and the certain capital improvements that that Authority is soliciting in this Request for Quotations ("RFQ") shall be referred to in this RFQ as the "Project". To that end, the Authority has prepared this RFQ for Furniture Procurement, including but not limited to Dining Area Tables and Chairs for the Stadium Ticket Office; Interior Concourse Benches; High Top Tables; Coffee Tables for Club Purple Couches. Those who respond to this RFQ shall be referred to as "Proposers".

The Project is located at the Stadium [and other additional adjacent land that has been acquired by the Authority in Minneapolis, Minnesota]. The Specification Documents identifying and indicating the scope of the Project are also incorporated within this RFQ as **Exhibit 1**. The Specifications Documents meet the standards required for a National Football League ("NFL") franchise, as well as additional standards established by the Authority. The Project must be completed by July 31, 2018 (the "Required Completion Date").

The successful Proposer to the RFQ will be engaged to provide Dining Area Tables and Chairs for the Stadium Ticket Office; Interior Concourse Benches; High Top Tables, Coffee Tables for Club Purple Couches including, without limitation:

- Coordinate the supply, delivery and installation of Dining Area Tables and Chairs for the Stadium Ticket Office; Interior Concourse Benches; High Top Tables; Coffee Tables for Club Purple Couches
- Proposer must provide a turn-key delivery and installation
- Two-year on-site warranty to repair or replace the parts and services constituting the project

B. Intent and Process of the Request for Quotations

This RFQ is focused on the selection of a Proposer who will provide the best value to the Authority for Dining Area Tables and Chairs for the Stadium Ticket Office; Interior Concourse Benches; High Top Tables, Coffee Tables for Club Purple Couches.

Proposers should have experience in the supply, delivery and installation of commercial grade furniture, similar to those that are the subject of this RFQ. It is the desire of the Authority to consider as part of its selection criteria the commitment of the Proposer to exert good faith efforts to comply with the plan of the Authority to ensure equitable opportunities for Minority Owned Business Enterprises ("MBE") and Women Owned Business Enterprises ("WBE") to participate in the Project. The successful Proposer or Proposers must also demonstrate the ability to exert good faith efforts to comply with workforce goals and targeted zip code hiring goals, and work with organizations to develop effective MBE, WBE and workforce recruitment efforts during the Project. The Authority has developed an Equity Plan and each Proposer should provide a plan describing how they will encourage the participation and utilization of appropriate workforce, MBEs and WBEs in the Proposers' performance of their services. MBEs and WBEs that are interested in acting as the Proposers for the Project are encouraged to respond to the RFQ.

C. Scope of the Project Requirements

D. Requested Qualifications

The Authority reserves the right and discretion to determine the qualifications and responsibility of the Proposers to perform the work and services that are the subject of the RFQ. It is the request and intent of the Authority that Proposers responding to the RFQ have the following qualifications.

- Experience history with the supply, delivery and installation of commercial grade furniture to large venues such as office campuses, arenas and/or stadiums, similar to the Project that is the subject of this RFQ.
- Ability to provide ongoing services that would include quick response repair or replacement of above referenced furniture items, in part or whole.
- The Proposer can provide references to support the quality and durability of the above referenced furniture, as well as support the quality of the Proposer's service response.

E. <u>RFQ Timeline</u>

By submitting a Quotation, the Proposer affirms that this timeline can be met.

F. Proposer Qualifications

The following items shall be included in a Proposal executive summary:

- Proposer's name and address of office that would have central responsibility for the work. Identify the business form of Proposer. If the proposed form of entity is a joint venture, please identify each joint venture participant and their respective percentage of participation. Provide a summary, on one page or less, describing why the Proposer is the most qualified to be the Provider for the Project.
- Proposer agrees that if it is proposing any services including installation work, it shall obtain worker's compensation insurance, vehicle insurance, and any other insurance required by applicable law or regulation. Proposer also agrees that it shall maintain commercial general liability insurance in commercially reasonable amounts, and that proposer shall provide upon request a certificate of insurance evidencing such coverage and additional insured status as requested. The Authority may terminate this purchase order if it determines in its sole discretion that the proposer's insurance coverage is not adequate for this project.
- Exhibit 1 <u>Scope and Specification Documents</u>. The Authority will complete the Scope and Specification Documents.
- Exhibit 2 <u>Proposal Scope of Services and Pricing Information</u>. There are two pages for this Exhibit. The first page is for the Proposer to define the scope of professional services, if any, that will be provided to the MSFA. The second page is for the Proposer to describe the equipment, materials, and installation labor, if any, that will be provided to the MSFA.

 Proposer must complete the Targeted Business Commitment and Information Form.
